We realize our company and processes are new to you and we are available to answer your questions.

If you have set up recurring payments through Associa Community Group, then Associa Community Group will turn off the recurring payments. You will then need to set up the recurring payments through our third-party payment vendor, Pacific Western Bank.

To make your payment online, visit our website www.mystreetva.com and click on the "Make a Payment" tab. You can make your payments two ways: 1. by credit card 2. by E-check. E-check payments are free but there is a charge for credit card payments. If you need help setting up payments, the Pacific Western Bank help desk will walk you through the process. You can reach them at (888-705-0600) during normal business hours. There is also an option to setup monthly recurring payments through Pacific Western Bank.

As a reminder, your annual assessment for 2024 is \$912.00 payable quarterly on January 1, April 1, July 1 and October 1 in the amount of \$\$228.00. Your next assessment is due on July 1, 2024. Payments are considered late if not received within 30 days of the due date. A late fee of \$27.56 will be charged to your account if payment is received after 30 days of the due date.

If you are more comfortable writing a check, you will still be able to do so. Coupon booklets will be issued upon request. Coupon booklet requests should be emailed to info@mystreetva.com.

IMPORTANT: All checks must be made payable to Bell Creek Single Family Residential Owners' Association and be sure your account number is referenced on your check. Checks payable to myStreet Community Management or Pacific Western cannot be processed.
